## GENTEXT/REMARKS/

Narr/(U) Updated OSD Guidance – Effective immediately, leave travel for DoD Service members is exempt from COVID-19-related travel restrictions. Military members (Regular AF and Reserve Component members in an active duty status) are authorized to take leave outside the local area but will be approved at a level no lower than the unit commander or equivalent. Leave within the local area can be approved at levels lower than the unit commander or equivalent.

## Additional Guidance

- 1. (U) Commanders and supervisors will conduct a risk assessment of the health status and travel itinerary for personnel requesting leave. (<a href="https://mypers.af.mil/app/answers/detail/a\_id/46605">https://mypers.af.mil/app/answers/detail/a\_id/46605</a>) Personnel should not travel if they display a fever or other symptoms consistent with COVID-19 or if they have had close contact with someone who has tested positive for COVID-19 within the past 14 days. Personnel will comply with any DoD, Federal, State, and local restrictions while in a leave status.
- 2. (U) Commanders and supervisors risk assessments should, at a minimum, include a review of State and local restrictions and pre- and post-travel health status assessment and travel screening. The health status assessment and travel screening should include the following: (1) Does the member have signs/symptoms of COVID-19 (https://www.cdc.gov/coronavirus/2019-ncov/symptomstesting/symptoms.html); (2) Has the member had contact (< 6 ft for more than 15 minutes) with anyone who has had signs and symptoms of COVID-19; and (3) Is the member familiar with how to self-monitor take if ill (https://www.cdc.gov/coronavirus/2019-ncov/symptomsactions testing/symptoms.html)? https://mypers.af.mil/app/answers/detail/a\_id/46605. Commanders and supervisors will establish a means of communication with personnel throughout the period of leave and the post-travel process, as well as prescribing actions for their particular circumstances.

- 3. (U) Except for paragraph 2.C.1., all other guidance contained in reference (b), remains in effect until further notice.
